**RESULT NOTICE OF WRITTEN EXAMINATION FOR THE POSTS OF ASSISTANT,

With reference to the advertisement no. Admn/Rect./774/2017 dated 05.12.2017 uploaded on ICMR/NIMR websites on dated 07.12.2017 with last date of receipt of applications as 16.01.2018 and subsequent written examinations held on dated 24.06.2018 and 01.07.2018, following candidates, on the basis of eligibility criteria as per the advertisement and marks obtained in the written test, have provisionally been shortlisted, for the skill test to be conducted in accordance with the advertisement.


