NOTICE OF SKILL TEST FOR THE POSTS OF ASSISTANT, UDC & LDC

In continuation of RESULT NOTICE no. Admn/Rect./774/2017/3203 dated 17.08.2018; following candidates are requested to appear for the Skill Test for the post of Assistant, UDC and LDC *on 29-09-2018 at NIMR.*

In case of tie up of final result after skill test, the merit will be prepared on the basis of age of the candidates as on last date of receipt of applications (16.01.2018) i.e. **candidates who are older in age will be placed at higher rank in the Merit.**

The candidates belonging to the OBC category are hereby requested to submit (if not submitted) the OBC caste certificate (**within 15 days of issue of this result notice or at the time of Skill test**) in the prescribed format (Annexure-A) issued as per Govt. of India instructions by the Competent Authority for **appointment to the post under the GOI**, which shall not be more than three years old from the last date of receipt of applications i.e. **16.01.2018.**


