

2. All the candidates as per Annexure-A are requested to appear for Personal Discussion/Interview as per above mentioned schedule along with following documents:-


- i) **All original certificates along with one set of all documents** in support of Date of Birth, Educational Qualifications, R&D/teaching/managerial experience certificate etc. The experience certificate should clearly indicate the designation/post held pay/remuneration, period and nature of job etc.
- ii) **One Identity Proof (in original)** with photo i.e. Aadhaar Card/PAN Card/Voter ID card etc.
- iii) **List of Publications** (along with copy)/ Awards/ Extramural projects.
- iv) **"No Objection Certificate"** from their present employer (if applicable).

3. Only outstation candidates called for the Personal Discussion/Interview as per the list attached shall be paid Second Class Sleeper Rail Fare through shortest route for attending the interview on submission of valid train tickets. In order to make speedy payment of their TA, they are required to bring duly filled Mandate Form (copy attached as Annexure-B) along with a copy of canceled cheque. **No spot payment shall be made.**




4. The candidature of all the candidates called for the Personal Discussion/Interview is provisional and subject to fulfilling all eligibility conditions/requirements as prescribed for the post & claimed by them in application.
5. Canvassing directly or indirectly shall disqualify the candidature.
6. ICMR/NIMR reserves the right to cancel the process, if considered necessary, at any stage of selection/appointment.
