- 3. Candidates have to submit the duly self attested copies of proof of their age, educational qualifications, experiences, testimonials etc. at the time of joining, if selected.
- 4. Selected candidates have to bring all the documents as mentioned above in Original while joining.

KINDLY NOTE: The shortlists candidates will be informed by 24<sup>th</sup> July 2020 for online interview to be held on 28<sup>th</sup> July 2020.
